Request Board **to approve** a resolution authorizing the issuance of its Senior Water Revenue Refunding Bonds, Series 2021 (the "Series 2021 Bonds") given certain parameters for the terms of the Series 2021 Bonds, including (i) the requirement that the principal and interest to be paid on the Series 2021 Bonds shall be less than the amount paid on the Prior Bonds; that the maximum aggregate principal amount of the Series 2021 Bonds shall not exceed \$500,000,000; that the maximum interest shall not exceed 4% on the Series 2021 Bonds and the final maturity date for the Series 2021 Bonds shall not be later than January 1, 2046 (collectively, the "Parameters"), as recommended by the Finance Committee, and (ii) the execution and delivery of the Financing Documents by the Board, and (iii) the consummation of all other transactions described in the recitals of the attached resolution and contemplated by the Financing Documents (the "Plan of Financing"); and **to authorize** the Board Chairman and Secretary/Treasurer to execute any necessary bond documents approving the bond issue; necessary to perform essential minimum functions of the governmental body.
