The Board reserves the right to award the bid on an individual or total cost of bid basis. The Board reserves the right to extend the contract, upon mutual consent of both parties, up to two (2) additional years. The Board reserves the right to cancel this bid within thirty (30) days with written notice. The Board reserves the right to cancel the contract due to non-satisfactory performance or if the vendor is found to violate the terms and conditions or does not correct any violations of specifications within two days after giving notice. The Board reserves the right to Rebid. The Board reserves the right to enter into a month-to-month contract with the consent of both parties.

SPECIFICATIONS FOR RESILIENT SEATED GATE VALVES

Revised: August 4, 2022

1.0 GENERAL REQUIREMENTS

1.1 DESCRIPTION/SCOPE

This specification applies to resilient seated gate valves to be used by The Birmingham Water Works Board for water distribution use.

1.2 QUALITY ASSURANCE

The manufacturer shall upon request, furnish a notarized certification to The Birmingham Water Works Board that all items were manufactured in full compliance with these specifications.

The entire process of the manufacture of items to be furnished under this specification shall be open at all times to the inspection of The Birmingham Water Works Board Engineer or his designated alternate. All defects shall be corrected to his satisfaction, or the material will be rejected. Approval at time of plant inspection shall not prevent rejection if defects are subsequently discovered.

In case of default by the vendor, the Board may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the vendor, the difference between the price named in the contract or purchase order and the actual cost thereof to the Board. Prices paid by the Board shall be considered the prevailing market price at the time such purchase is made.

1.2.1 REFERENCES

American Water Works Association (AWWA) C509, C515, C550, C110, C111 American National Standards Institute (ANSI) A21.10, A21.11, B2.1, B16.1 American National Standards Institute (ANSI)/National Science Foundation (NSF) 61 American Iron and Steel (AIS) requirements

When reference is made in these specifications to American Water Works Association (AWWA), American National Standards Institute (ANSI), American Society for Testing and Materials (ASTM), American Iron and Steel Institute (AISI), National Science Foundation (NSF), or other standards, it is understood that the latest revision thereof shall apply. The manufacturer should especially note that this part of the specifications applies to all items with additional requirements set forth for each type.

1.3 SUBMITTALS

Quantities and sizes of required items are shown on the attached "Bid Form". The manufacturer and manufacturer's catalog number for each item listed on the "Bid Form" shall be inserted in the column headed "Manufacturer & Catalog Number".

Any bidder proposing to furnish any product not listed as acceptable in this bid must first obtain written approval from the Board's Engineering Department, prior to submission of his bid.

If bidding a product manufactured by another firm, a letter must be submitted from the actual manufacturer of that product giving your company as agent authority in Birmingham, Alabama to bid that product.

The letter may be a blanket letter from the manufacturer renewable at the beginning of the calendar year giving your company authorization to bid and sell the products that were (are) quoted. The letter may cover as many items as are requested by your company.

Each bidder shall provide, prior to bidding, a complete brochure including the following data for the valves proposed:

- 1. Complete installation and maintenance instructions.
- 2. Complete operational data with illustrated cuts.
- 3. A list on which will be indicated the material from which each part is fabricated.
- 4. Detailed drawings of proposed valves on which shall be an itemized parts list and manufacturer's part numbers. Drawings shall contain sufficient detail cuts for complete dimensional information.

The manufacturer shall furnish a notarized certification to the Water Board that all items were manufactured in full compliance with these specifications.

Also, the manufacturer shall show evidence that the valves furnished in this Bid meet the requirements of all tests set out in AWWA C509 and/or C515.

1.4 PRODUCT DELIVERY

Shipment of all items will be required as soon as possible, and prices quoted shall be firm until shipment of all items is complete.

Failure by bidder to meet promised shipping schedule, shall constitute the Boards' right to cancel all or any part of order awarded to successful bidder.

Prices quoted shall be F.O.B. destination, which is the Warehouse address of 3505 Messer Airport Highway, deliver thru entrance at 3500 Second Avenue North, Birmingham, Alabama 35222.

All items listed and required on the attached "Bid Form" are to be in compliance with The Birmingham Water Works Board specifications.

Mechanical Joint gate valves used as inline or tapping valves shall be shipped completely assembled (including end joint accessories) in an open top truck or flat bed trailer.

Pack so valves and accessories are delivered in perfect condition. Damaged valves and accessories to be subject to rejection.

ALL SHIPMENTS MUST BE MADE IN AN OPEN TOP TRUCK OR FLAT BED TRAILER.

2.0 PRODUCTS

2.1 SERVICE CONDITIONS/DESIGN CRITERIA

Resilient seated gate valves shall conform to the requirements of AWWA Standard C509 and/or C515 latest revision and specific requirements of these specifications and conditions. Although not addressed in the applicable AWWA standards, all 2-inch threaded valves with T-head operating nut shall comply with the design parameters set forth in AWWA C509 and/or C515.

Valves shall be manufactured and tested to meet or exceed all requirements of AWWA C509 and/or C515 latest revision. The 2-inch threaded valves with T-head operating nut shall conform to the design, fabrication and testing requirements of AWWA and specific requirements of these specifications.

2.1.1 AMERICAN IRON AND STEEL (AIS) REQUIREMENTS

All iron and steel products in this specification must comply with American Iron and Steel (AIS) requirements. The requirements were established in the 2014 Consolidated Appropriations Act (CAA) under Section 436 (Public Law 113-76) which was made permanent in 2014 by the Water Resources Reform and Development Act amending the Clean Water Act under Section 608 for all Clean Water State Revolving Fund (CWSRF) loan recipients. The Water Infrastructure Finance and Innovation Act of 2014 (WIFIA Program) administered by the U.S. Environmental Protection Agency (EPA) mirrors the Clean Water and Drinking Water State Revolving Fund programs (refer to Statute 33 U.S.C. §3914) as it relates to AIS requirements.

2.1.2 MANUFACTURER AIS CERTIFICATION LETTER:

Products made primarily of iron or steel (greater that 50% iron or steel, measured by material cost only) must be produced in the United States. Product manufacturer must certify products and/or materials provided by manufacturer are in full compliance with the American Iron and Steel (AIS) requirement as mandated in the Environmental Protection Agency's State Revolving Fund Programs. The Water Works Board of the City of Birmingham (Water Board) shall request and obtain AIS Certification Letters from iron and steel manufacturer supplying products and/or materials to the Water Board to be incorporated into projects.

2.2 <u>DETAILS OF CONSTRUCTION</u>

All items furnished under this contract shall be manufactured or assembled by the manufacturer and shall carry his name or trademark permanently cast and readily visible on the body of the valve. All markings shall be cast integral on the valve body with the size of valve, manufacturer's name, year manufactured and 250 to signify working pressure.

The resilient seated gate valves are to be iron body and bonnet, non-rising stem using the compression of the resilient material against the contour of the valve body for sealing.

Valves shall have a clear, unobstructed waterway when fully opened and shall be at least as large as the pipe inside diameter for which it is intended.

All internal surfaces including the internal cavity of the gate shall be coated with epoxy to a minimum thickness of 8 mils. Said coating shall be non-toxic and impart no taste to water and shall conform to AWWA C550 latest revision. The outside of the valve is to be coated with the same epoxy such that

all exposed external surfaces, including end connection bolt holes, body-to-bonnet bolts holes etc., shall be coated.

Valves shall be sealed with two o-ring stem seals with one o-ring located above and one o-ring located below stem collar. The area between the 0-rings shall be filled with lubricant to provide lubrication to the thrust collar bearing surfaces each time the valve is operated. One anti-friction washer shall be located below and one anti-friction washer shall be located above the thrust collar.

The sealing mechanism shall consist of a ductile or cast iron gate with a resilient seat bonded or mechanically attached. It shall be designed so that compression set of the rubber shall not affect the ability of the valve to seal when unbalanced pressure is applied to either side of the gate. The sealing mechanism shall provide zero leakage at **250 PSI working pressure** when installed with the line flow in either direction.

The gates in sixteen inch and larger size valves shall be provided with a drain in the bottom to flush the internal cavity of foreign material each time the valve is opened.

The threaded ends of valves are to have female iron pipe threads and shall conform to ANSI B2.1. **Threaded valves** shall **OPEN TO THE LEFT** (counterclockwise).

2-inch valves shall have small T-head operating nut and short stem adhering to the "Board's Specification" as set forth below.

The operating nut is to be T-head design and is to be made of ductile or cast iron in accordance with the dimensions as shown on the drawing, which is attached. The design of T-head operating nut shall not allow a standard 2" square valve key to operate the valves in this specification

2-inch threaded valves to be used as tapping valves: The valve opening is to be a full 2-inch diameter all around in order to accommodate a 2-inch tapping bit (1-7/8 inch).

3-inch valves shall have a black 2" square operating nut.

3-inch threaded valves to be used as tapping valves: The valve opening is to be <u>a full 3-inch</u> diameter all around in order to accommodate a 3-inch tapping bit.

The flanged end of valves shall conform to ANSI/AWWA C110/21.10, flat faced drilled in accordance with ANSI B16.1 Class 125, no jointing accessories required to be furnished on the Flange-Flange Gate Valves. **Flanged valves** shall **OPEN TO THE LEFT** (counterclockwise) with wheel operators marked in the direction to open.

The mechanical joint ends of valves to be used as inline valves shall conform to ANSI/AWWA C111/A21.11 complete with all necessary jointing accessories. MJ Valves shall OPEN TO THE RIGHT (clockwise), and be so marked on the red 2" square operating nut.

Valves to be used as tapping valves shall be furnished with mechanical joint ends for one end and flanged ends for the other end. The flanged end shall conform to dimensions and drilling of ANSI B16.1 Class 125, and shall be flat faced. These valves are to be furnished complete with all jointing accessories fully assembled, both flanged and MJ ends. Valves to be used as tapping valves are to be constructed so that they will be compatible with standard Mueller Tapping equipment and full size shell cutters. The connecting flange of these valves mating with the tapping machine must be parallel and concentric with the waterway to provide proper alignment for the tapping operation.

Valves sixteen (16) inches in diameter and larger shall be lay down type with bevel gears enclosed in a weatherproof case that is suitable for direct bury. The minimum gear ratio shall be 2 to 1. The screw (stem) is to be completely enclosed in the bonnet or the gear case.

Such records shall include, but not be limited to, accounting records, written policies and procedures; subcontract files; all paid vouchers including those for out-of- pocket expenses; other reimbursement supported by invoices, ledgers, cancelled checks, deposit slips, bank statements, journals, original estimates, estimating work sheets, contract amendments and change order files, back charge logs and supporting documentation, insurance documents, payroll documents, timesheets, memoranda and correspondence (written and electronic).

General Mission Statement

The Water Works Board of the City of Birmingham ("BWWB") has adopted a voluntary Historically Underutilized Business ("HUB") Program designed to encourage the participation of HUB firms in construction projects and goods and services. To that end, the BWWB will not exclude any firm from participation in, deny any person benefits of, or otherwise discriminate in connection with the award and performance of BWWB construction contracts and goods and services bids based on racial, gender, social, or economic status.

It is the intent of the BWWB to foster competition among contractors, suppliers and vendors that will result in better quality and more economical services for the BWWB. Under this program, the BWWB has established a goal of 30% participation of HUB firms for services required for BWWB construction projects and goods and services. The BWWB's stated goal will not be the determining factor in construction and goods and services contract awards; rather bidders must demonstrate compliance with the Good Faith Efforts, more particularly outlined below, toward meeting said goal.

Failure on the part of a bidder to fully submit the information required herein may be considered by the BWWB in evaluating whether the bidder is responsive to bid requirements.

NOTE: If Bidder is a direct manufacturer/direct supplier of the goods or services sought in this Bid and has no opportunities for HUB participation, Bidder should fill out the Direct Manufacturer/Supplier Certification Form 6.

Program Goals

- To ensure nondiscrimination in the award and administration of BWWB construction contracts and goods and services.
- To help to remove barriers to the participation of HUB firms in receiving BWWB construction contracts and bids for goods and services.
- To create a level playing field on which HUB firms can compete fairly for BWWB construction contracts and bids for goods and services.

Definitions

- 1. Historically Underutilized Business (HUB): A business formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by one or more American citizens or permanent resident aliens who are: Minority Business Enterprise (MBE); Women's Business Enterprise (WBE); Disadvantaged Business Enterprise (DBE) and Disable Veteran Business Enterprise (DVBE); (herein sometimes collectively referred to as HUB).
- 2. Minority Business Enterprise (MBE): A business that is formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by a person who is a member of the following groups: African/Black Americans; Hispanic Americans; Asian Pacific Americans; Subcontinent Asian Americans; Native Americans or American Women.

- 3. Disadvantaged Business Enterprise (DBE): A business that is formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by one or more socially and/or economically disadvantaged individuals. A socially disadvantaged individual is one who has been a subject of racial, ethnic or gender bias because of their membership in a group. An economically disadvantaged individual is one whose ability to compete in the free enterprise system is impaired due to diminished opportunities to obtain capital and credit.
- 4. Women's Business Enterprise (WBE): A business enterprise formed for the purpose of making a profit and is at least 51% owned, operated and/or controlled by American citizens or permanent resident aliens who are women.
- 5. Birmingham Construction Industry Authority (BCIA): The BCIA (Website www.bcial.org) is a voluntary program developed to maximize HUB participation in the construction industry of the Birmingham area. Owners of construction projects in both the public and private sector participate in the BCIA's efforts to increase the participation of HUB in their construction projects. HUB firms are certified as MBE, DBE or WBE by the BCIA and receive business counseling and technical assistance provided by the BCIA staff.

Affirmative Steps for Good Faith Solicitation

All bidders must submit to BWWB in their sealed bids evidence of the following Affirmative Steps taken to utilize IIUB's. These Affirmative Steps are required methods to ensure that HUB's have the opportunity to compete for contracts with BWWB.

It is up to BWWB to make a fair and reasonable judgement whether a bidder/prime company made adequate good faith efforts. The BWWB will consider the quality, quantity, and intensity of the different kinds of efforts that the bidder/prime company made. The efforts employed by the bidder/prime company should be those that one could reasonably expect a bidder/prime company to take if the bidder/prime company were actively and aggressively trying to obtain HUB participation sufficient to meet the HUB Program goals.

Below is a list of types of steps that BWWB will consider as part of the bidder's/prime company's good faith efforts to obtain HUB participation. It is not intended to be a mandatory checklist, nor is it intended to be exclusive or exhaustive. Other factors or types of efforts may be relevant in appropriate cases:

- 1. Ensure HUB's are made aware of contracting opportunities to the fullest extent practicable through outreach and recruitment activities. Soliciting through all reasonable and available means (e.g. attendance at pre-bid meetings, advertising, written notices and notifying BCIA, or other available sources) the interest of all certified HUB's who have the capability to perform the work of the contract. The bidder/prime company must solicit this interest within sufficient time to allow the HUB's to respond to the solicitation. The bidder/prime company must determine with certainty if the HUB's are interested by taking appropriate steps to follow up initial solicitations.
- 2. Make information on forthcoming opportunities available to HUB's and arrange time frames for the submission and finalization of contracts and established delivery schedules, where the requirements permit, in a way that encourages and facilitates participation by HUB businesses in the competitive process. This includes, at a minimum, seeking and receiving solicitations for contract bids or proposals 2 calendar days before sealed bids are due to BWWB.
- 3. Once the contract has been awarded, the prime company should continue to use its best efforts to further increase HUB participation toward reaching the BWWB stated goal.
- 4. Consider in the bidding process when competing for large contracts the possibility of dividing total requirements whenever economically feasible into smaller tasks or quantities to permit maximum participation by HUB's in the competitive process.

- 5. Encourage contracting with a consortium of HUB's when a contract is too large for one such firm to handle individually.
- 6. Negotiate in good faith with interested HUB sub-companies. Evidence of such good faith negotiations should include the names, addresses, and telephone numbers of HUB sub-companies that were considered; a description of the information provided regarding the request for proposal, request for qualifications, plans and specifications for the work selected for contracting; and evidence as to why additional agreements could not be reached for HUB sub-companies to perform the work.
- 7. Use the resources of the BCIA and the other resources identified above.
- 8. Provide documented proof of steps taken to comply with items 1 through 7 above.

Bidders/Prime companies must submit or provide the following HUB Forms as outlined below:

- 1) <u>Acknowledgement of HUB Program (HUB Form 1).</u> All bidders are to read, sign and <u>include in their sealed bid</u> the Acknowledgement of HUB Program, indicating that they fully understand and will voluntarily participate in and follow the guidelines and instructions included in the BWWB HUB Program.
- 2) <u>HUB Compliance Form (HUB Form 2)</u>. This form must be completed <u>and included with all</u> <u>sealed bids</u> for goods and services/public works with the BWWB.
- 3) <u>HUB BID SOLICITATION NOTICE (HUB FORM 3).</u> All bidders shall complete this form and submit to the BWWB and the BCIA no later than seven (7) days after the scheduled date of the pre-bid conference. This form may be submitted in person at the pre-bid conference. Prospective bidders are to <u>submit with their bid documents a copy of their HUB Form 3 with acknowledgement of receipt box completed by BCIA.</u> (This form is used for Public Works bids only)
- 4) <u>HUB Sub-company Participation Form (HUB Form 4- (Part 1&2).</u> This form gives a HUB sub-company the opportunity to describe the work the HUB sub-company received from the bidder/prime company, how much the HUB sub-company was paid, and any other concerns the HUB sub-company might have. <u>Bidder/prime company shall provide copies of HUB Form 4 to all HUB sub-companies.</u>
- 5) <u>HUB Sub-company Performance Form (HUB Form 5)- (Part 1&2).</u> This form captures an intended HUB sub-company's description of work to be performed for the bidder and the price of the work proposed to be performed by the HUB sub-company. This form is to be provided by the bidder to each HUB sub-company and <u>submitted along with the HUB Compliance Form included in the bid</u> documents.
- 6) <u>HUB Direct Manufacturer/Supplier Certification (HUB Form 6).</u> This form captures the direct manufacturers or suppliers of goods and services sought in the bid and have no distributors, wholesalers, retailers or other intermediaries, and thus do not have any opportunities for HUB participation in this Bid. (This form is used for Goods and Services bids only)

7) <u>HUB Sub-company Utilization Form (HUB Form 6- (Part 1&2).</u> This form captures the bidder's/prime company's intended use of an identified HUB sub-company and the estimated dollar amount of the work. This form is to be completed by the bidder/prime company and submitted with the HUB Compliance Form included in the bid documents.

(This form is used for Public Works bids only)

8) <u>Changes to Approved HUB Compliance Form (HUB Form 7).</u> If any changes, substitutions, or additions are proposed to the sub-company identified in the bid or any other time during the work, the <u>bidder/prime company must submit this information to BWWB for prior written approval</u>. No changes to the sub-company can occur without the BWWB's prior written consent.

(This form is used for Public Works bids only)

- 9) <u>Monthly Report Form (HUB Form 8).</u> With each monthly pay request submitted to BWWB, the prime company is required to submit updated monthly HUB Form 8 reports which identify HUB firms' participation. Monthly pay requests <u>will not be processed</u> without the updated list of HUB firms.

 (This form is used for Public Works bids only)
- 10) <u>Project Close-out Report (HUB Form 9).</u> Upon completion of the contract and prior to final payment or release of retainage, the prime company is required to submit a **HUB Form 9** Project Close-Out Report that includes a final listing of all HUB participants on the project. The Project Close-Out Report, with documented HUB participation, is a <u>prerequisite</u> to process the final pay request.

(This form is used for Public Works bids only)

Sub-companies must be certified as HUBs in order to be counted toward the bidder's/prime company's HUB accomplishments.

The documentation of the good faith solicitation efforts must be detailed in order to allow for satisfactory review. Such documentation might include fax confirmation sheets, copies of solicitation letters/emails, printouts of the online solicitations, printouts of online search results, affidavits of publication in newspapers, etc. The bidder/prime company is strongly encouraged to follow up on each written, fax, or email solicitation with at least one logged phone call.

The bidder/prime company must employ the affirmative steps set out above to subcontract with HUB, even if the bidder/prime company has met its goal of HUB participation.
